Presidents Message

Most people don't enjoy change. The seasons remind us that change is in fact a part of life but that doesn't stop most of us from complaining every time we have to change our clocks. I'm sure you are all aware that change is coming to Four County with the retirement of Sharon Sweeny our Executive Director. Sharon has been dedicated to our organization for over 25 years and has huge shoes to fill!



In September the Board of Directors agreed that we wanted to find someone to help facilitate our search. I spoke to Scott Bischoping, Superintendent of BOCES. During our conversation he offered to use BOCES as a mechanism to bill for Four County services thereby allowing districts to receive state aid for our dues, as well as programs and meals. Making this change would, of course, also introduce some issues we do not currently face: specifically, our employees would be BOCES employees.

The reason to decide on this issue now is because being a BOCES service will affect our new director's benefits as well as make it impossible to hire someone who has retired from state education and is under the age of 65. (They would not be permitted to work for BOCES and make more than \$30,000 per year.)

This issue has been discussed at length at two Board of Director's meetings. At our last meeting it was decided to take this information back to our boards so we could all have our boards' input when we vote on this issue at our November 28th meeting. If you have any questions about this topic, or any other, for that matter, please contact me.

I encourage every district to send a representative and have a voice at our next Board of Director's Meeting on November 28th.

In addition to attending general sessions and workshops, and representing their boards as delegates to the Annual Business Meeting, many provided assistance by presiding over workshop sessions. Two Four County member districts were featured at workshops. Presentations were offered by Seneca Falls Superintendent **Bob McKeveny**, who talked about "Board Member Handbooks Strengthen Relationships" and by Marion Principals **Cathy Hauber** (formerly of the Elementary School) and **Nick Ganster** (High School) on the topic "Personalized Learning: The Future of Education". Lending assistance as workshop Presiders were: **Lynn Gay** (Wayne-Finger Lakes BOCES), **Russ Harris** (Newark), **Jim Koehler** (Dundee), **Joe McNamara** (Seneca Falls/Wayne-Finger Lakes BOCES), **Jeff Morehouse** (Penn Yan), **Anne Morgan** (Wayne-Finger Lakes BOCES) and **Heather Zellers** (Seneca Falls). **Mary Church** (former member of South Seneca and now with TST BOCES) was also in attendance and serving as a presider. LEGISLATIVE UPDATE

From Legislative Committee Chair - Heather Zellers

The Legislative Committee is working to define and understand the local issues facing our districts. In October, the committee participated in a logic model exercise to encourage a better understanding of our specific State issue asks and how these would impact our districts.

The group explored what was needed to meet our needs, what districts would do with the additional resources, what would be the immediate impact for districts, and how these changes would affect long-term planning. This exercise will help prepare the committee members and enable them to craft a compelling story for their district and answer potential questions from legislators in Albany.

Along with working on the position papers, the Chair and Executive Director have met with representatives from Congressman Reed's, Collins' and Katko's offices to discuss the impacts of the federal tax changes to local districts.

NYSSBA representatives have accompanied local school boards at meetings that address changes to the S.A.L.T. deductions, allowable uses of the 529 educational savings plan, and repeal of provisions for school bonds that include repairs, construction and energy conservation. Four County will continue to support the State in its fight to protect public education on a federal level. Please be sure to answer NYSSBA's calls to action.

Our voices matter!

Four County is taking the lead in bringing together legislative representatives from all the regional school board associations and NYSSBA. We hope to have a stronger united voice in Albany by collaborating around a single message. We will keep you updated as we work to coordinate this event.

Thank you to the committee members from Newark, Wayne, Penn Yan and BOCES for stepping up to support our outreach program as Legislative Liaisons. The power of Four County is the power of connection.
