To Speak at the Four County School Boards Association's Annual Meeting on May 23, 2023



William "Billy" Green, Jr. A Chemistry Teacher who first tutored fellow students in an abandoned building as a homeless teenager has been named New York State's Teacher of the Year.

We are proud to report that the New York State Teacher of the Year, Billy Green, Jr., will be our featured speaker at our Annual Meeting in May.

On September 13, 2022, the New York State Board of Regents announced that Mr. Green was named the 2023 New York State Teacher of the Year.

Billy Green is presently serving as a chemistry teacher at A. Philip Randolph Campus High School in

Manhattan and will be recognized with other state teachers of the year at a White House reception this spring. NYSED will also put forth Billy's name as the nominee for the 2023 National Teacher of the Year.

New York State Commissioner of Education, Dr. Betty Rosa said, "Billy Green found his calling in the classroom, something I saw firsthand when I visited him with his students. He ignites a spark in them, imparting a love for life-long learning and inspiring them to take charge of their personal and academic responsibilities."

MESSAGE FROM THE PRESIDENT

I had the pleasure of presenting gift card to the Four County School Board Logo Contest winners it is always a pleasure to interact with students which is the real reason we do this job.

We are in budget season and as board members we are experiencing many pressures. We got our wish, foundation aid is increasing back to levels we got in prior years, but we have many new issues that face us that require more money and not all of that increase can go to academics. Safety and security, alternative programing and technology are requiring increasing funds.

We play lip service to mental health but are we doing enough? Is the bullet proof glass in the windows and advanced door locks more important than doing all we can to help our troubled youth?

Recent articles in the Washington post talk entitled: The crisis in American girlhood

Teen girls 'engulfed' in violence and trauma, CDC finds "Teen girls across the United States are "engulfed in a growing wave of violence and trauma," according to federal researchers who <u>released data</u> <u>Monday</u> showing increases in rape and sexual violence, as well as record levels of feeling sad or hopeless.

Nearly 1 in 3 high school girls reported in 2021 that they seriously considered suicide - up nearly 60 percent from a decade ago - according to new findings from the Centers for Disease Control and Prevention. Almost 15 percent of teen girls said they were forced to have sex, an increase of 27 percent over two years and the first increase since the CDC began tracking it."

Jean Twenge, a psychology professor at San Diego State University said that increases in most measures of poor mental health in the past decade were more pronounced for girls than boys. She said part of the problem is that digital media has displaced the face-to-face time teens once had with friends, and that teens often don't get enough sleep. Adding to those influences are the hours teens spend scrolling social media. For girls, she said, this often means "comparing your body and your life to others and feeling that you come up wanting."

Some of the most alarming data collected by the CDC involved the rise in suicidal thoughts among teen girls -24 percent of teen girls have made a plan for suicide while 13 percent have attempted it, almost twice the rate for boys. Suicidal thoughts are serious but for every student contemplating suicide how may more are so sad that they can't cope with in their environment and act out in other ways.

As we advocate with our state and federal representatives let's not let the let our guard down and as we go into the budget process please think of the balance between safety and security and what we can do for our troubled students and it's effect on our communities.

We need do strong security plans and trained personal to keep our children safe in any event, but what is the balance? Will we save more students by investing in mental health personal or the instillation of bullet proof glass? Why do we have to choose?

One of our program speakers spoke about a "Financial Cliff" happening in school year 2023/2024 because of the ending of "COVID dollars". Many districts throughout the States may have used additional monies for staffing that they wish or want to keep or other recurring costs for which they may not have the funds to continue to do so in coming years. Hopefully our Superintendents and Business officials are on top of all of this, as is NYSSBA.

I wish you all a successful school year as the next few months usually brings many district musicals and other fine arts performances and the start of spring sports. Looking forward to longer lighted days and hoping your budget development for the next school year goes smoothly.

MESSAGES FROM THE LEGISLATIVE COMMITTEE CO-CHAIRS

Greetings, fellow school board members!

Late winter can be a pretty dull season for most of us. But for the 4 County Legislative Committee, it's one of the most exciting times of the year. Throughout the fall and winter, the committee has been gathering information from members like you about the needs and priorities in our school districts. We use this information to put together position papers that outline how we hope our government representatives can partner with us to support our students. Major themes this year included addressing staffing shortages, maintaining equitability and predictability in funding, and promoting mental health and wellness for students and staff. After lots of discussion, revision, and editing, the position papers are ready for their big day: Lobby Day. This year it took place on February 15. Four County Legislative Committee and NYSSBA members went to Albany to meet with senators and members of the assembly. We prepared talking points to share at each meeting and had great discussions with the folks who represent us: Senator Pam Helming, Assemblyman Brian Manktelow, and Assemblyman Phil Palmesano, along with staff representing the offices of Assemblywoman Marjorie Byrnes and Senator Thomas O'Mara.

During these discussions with our Legislators, we learned how problems can be connected. For example, electric buses. The change toward electrification is not only happening in our schools but also our community: shifts in how we cook or heat our homes as well as transportation. Several Legislators pointed this out with this question to follow: "How is our electrical grid going to handle this?" Their answer is that the technology is not developed enough to do that yet. Common thought between us was we see some benefit to electrically run items, but only when the time is right. The Legislators we meet with on Lobby Day request further data to create a portfolio of our needs to share with their committees. This portfolio will be supplied by our Legislative Committee via follow up letters going out the next couple of months. Each letter will have a focused issue. Be on the lookout for emails from us asking for data from your district.

Education is such an important part of what New York State does, but for representatives, it's only one of many big issues on their plates. As school board members, education is our top priority. That's why Lobby Day can be so valuable – the chance to make a connection and remind representatives of the importance of what we do is also a chance to build bridges of understanding and collaboration. We can advocate for what students need and talk about how to make it happen.

If these opportunities sound exciting and valuable to you, we'd love for you to join us at Legislative Committee meetings. These occur monthly on Saturday mornings over Zoom, and the next scheduled meeting will be March 11. We hope you can join in this advocacy process!
