The legislative committee has continued to work through the summer to come back this fall with a renewed energy around the vision of "Inform, Influence and Engage"! We met in June for a brainstorming session that focused on reviewing the by-laws and policies for the Legislative Committee and starting to work on goals for the coming year. We are excited about the possibility of hosting a workshop and the creation of legislative liaisons for boards that may be unable to participate in meetings and events. Federal issues surrounding education funding and related services continue to be a legislative priority. Over the past few weeks, Four County representatives have teamed up with NYSSBA during meetings with local Federal leaders. Sharon and Lynn Gay attended a meeting with Congressman Collins. Sharon and Heather attended a meeting in Congressman Reed's office. Title II funding and Medicaid were the focus. Information regarding Title II funding levels for each of the Four County Component districts was shared. Representatives stressed the importance of protecting professional development as we begin to implement ESSA and providing our teachers and administrators with tools to address the rapidly changing needs of our students.

The first Legislative Papers Meeting is scheduled for Saturday, September 16 at 8:00am.
