

ESSA Flexibilities Guide

Some of our districts are required to provide some level of reporting this year, and all districts next year, pending the development of NYS reporting Requirements.

Last week, the U.S. Department of Education released a publication detailing the flexibilities. The guide highlights the key flexibilities afforded to States and districts in ESSA, including fiscal and programmatic options across the Elementary and Secondary Education Act (ESEA). In addition, the Department has made a parent friendly version of the Guide available. The second link is a parent's guide that helps those not professionally involved in the education of their children understand ESSA at a high level. This is a complicated issue / requirement coming down from Washington and modified by NYSED that you will want to become familiar with. More to come as NYS develops their requirements.
