COMMISSIONER'S ROUND-TABLE REPORT By Joe McNamara President Seneca Falls BOE/member W-FL BOCES BOE

NYSSBA arranged a roundtable event for representative Board of Education members from around the State to meet with Commissioner King. I was one of nineteen board members to attend the roundtable, hosted by the Capitol Region BOCES, on July 18th, 2014 in Albany.

The event began with a presentation by the Capitol Region BOCES staff that outlined: Regional Information Centers (RICs) database of state and local assessment data that is available free of charge to all school districts

The role of data in Board of Education decision making NYSBA then followed with a briefing on the Federal Equitable Access to Effective Teachers Initiative that aims to have highly effective teachers in all low performing schools

Finally, the round-table session with Commissioner King began. Our discussion included: Attendees' responses to Dr. King's question "what was the best thing that happened in your schools this past year?" Responses included action toward implementing the Common Core, efforts to inform parents and others about the changes, and many comments about changes to the way districts are doing things.

The Commissioner reinforcing the value of data, the importance of quality data, and the ability to understand and use data properly


The "opt out" challenge and the importance of educating parents and others about the value of testing

Concerns about the testing of special education students and the coming ability to provide adaptive tests for these students

Concerns about the compatibility of tests and text books, avoidance of bias in testing, and quality in the wording of questions

Reaffirmation by Dr. King that Person is developing the tests within NY State guidelines and review by NY educators. Regents' exams are written by NY State teachers and subject to a bias review process.

The Commissioner's Round Table event demonstrates the Commissioner's and NYSSBA's acknowledgement of the importance of strengthening communication, sharing best practices, and building collaborative relationships among all stakeholders, from SED to BOE members across the State.
